**4. *Review and vote on IRC sprinkler amendments.***

There was a discussion regarding the sprinkler provisions in the IRC, specifically P2904. This section contains the prescriptive methods for installing residential sprinklers. P2904 is referenced throughout the IRC and the question is are these provisions available to be used and is there an appetite for building departments to review and inspect sprinklers. It is not clear if a license from the State Fire Marshal is required.

No one knew if fire departments would allow an IRC designed sprinkler system. It was decided that sprinklers should be regulated by the fire departments. The group thought there was no need remove all the references to P2904 in the IRC. Any reduction in fire resistive construction through sprinklers that reference P2904 only can be handled by accepting a complying NFPA system through alternative means.

**5. *Verify new effective date of the 2012 package.***

The group was in agreement that the effective date of the amendment package would be September 1, 2013.

**6. *Present support statement for signatures.***

The chair provided a sample support letter that could be signed by all participating organizations. The names of the representatives from the participating organizations will need to be forwarded to the chair.
