- CODE AMENDMENT PROCESS:
- In today's Board Meeting, the Board voted to accept the 2024 Northern Nevada Code Amendments package. Bob brought paper copies for review and informed everyone that the package is posted online at [nnicc.org](http://nnicc.org) for viewing.

- Emilio thanked Bob and Abbey for all their hard work.
- Bob thanked Abbey for her hard work on updating the documents. They're typed in an ADA compliant font and are very easy to read. She spent many hours re-formatting and correcting typos that were carried over from previous years.
- Bob thanked all Jurisdictional and Industry members who participated in the Code Amendment process. Not many new Amendments were proposed or adopted. As a Jurisdiction we invite stakeholders to participate, because we value their input.
- Hundreds of staff hours were used on the IECC (International Energy Conservation Code) Amendment process. The new Administration for the Governor's office of Energy acknowledges that they presented struggles and prolonged the process.
- There were special interest groups who wanted us to adopt all Appendices in the IECC. Bob asked them to present their concerns to City Council and seek approval with each individual Jurisdiction.
- Bob will present the Amendment package to BANN (Builders Association of Northern Nevada) next month on behalf of NNICC and meet with AGC (Associated General Contractors) to share the changes. Meeting members expressed interest in attending both meetings; Bob will share the dates and times once the meetings are set.
- Emilio asked for a motion for all members in attendance to approve the 2024 Northern Nevada Code Amendment package. 1<sup>st</sup> motion by Dan, 2<sup>nd</sup> by Paul. There were no objections by members; 2024 Northern Nevada Code Amendment package approved.
