MINUTES

1. CALL TO ORDER / ESTABLISH QUORUM:

- A quorum was established, and Emilio Lozada called to order the NNICC General Meeting at 11:44 am, on June 18th, 2025.

2. APPROVAL OF MINUTES FROM GENERAL:

- Emilio Lozada asked for a motion to approve the 3-19-25 General Meeting Minutes. Teresa noticed a typo in the Committee Report. BANN was listed as BAAN. Rob made a motion to approve by the minutes with the typo, Jera 2nd the motion. 3-19-2025 General Meeting Minutes are approved as-is.
